EXPECTATION V/S REALITY

throw us out, and we are outdated in the profession. If we read, we survive. We sustain this by doing R&D of using technology and applying it to the library, and then we minimise the gap between reality and expectations.

REIMAGINE LIBRARY-DYNAMIC LIBRARY GOVERNANCE BY DR. SHAILESH YAGNIK

INTRODUCTION: Reimagine library:

Reimagining a library is a continuous process, such as channeling new reservoir water. To absorb new knowledge, one must learn, unlearn, and relearn the knowledge to keep a library up-to-date and relevant to the current scenario.

Dynamic Library Governance:

Dynamic: This term refers to dynamic as thinking out of the box, full of creativity, full of energy, full of new and exciting ideas, continuous and productive, always active, changing, enthusiastic, and effective action.

Library: The library is a social institution.

Governance: The Governance Institute has defined governance as "the system by which an organisation is controlled and operates and the mechanisms by which it, and its people, are held to account.

Ethics, risk management, compliance, and administration are all elements of governance. As per Bradshaw & Fredette 2009; Institute on Governance, Sporn, 2006 quoted in Revitt and Luyk, governance is about the structure and process of making decisions and how stakeholders make their voices heard.

A library is an institution within the university system, so It is expected to function with good governance. I would like to quote the book "Team of the Teams: New Rules of Engagement for a Complex World" by General Stanely McChrystal. This is an indispensable guide to organisational change. An excellent library supported by quality collections is an asset to academia. It contributes to the intangible assets of

knowledge seekers engaged in studying, teaching, self-learning, research, consulting,

writing cases and patents, conducting training programs, etc. The library enables the academic community to access information and to develop the skills and confidence to improve their future and the nation's economy. Information can make a massive difference to students in finding a job, staying healthy. individuals' understanding their of rights, protecting and national nature, development. Knowledge helps them to become a responsible citizen.

• Library Governance

Vision (Dream destination) and Mission (Game plan):

Every library has its vision and mission, which vary in words, but the ultimate objective is to give the best support to the academic community.

Broad Structure: Authority (VC) -Library Governance/Committee - End Users---Library Governance is the catalyst between the authorities and the end users. The purpose of the Library Committee is to act as a channel of communication dialogue between the University Library and its end users. The Committee's main objective is to aid in the establishment of a bridge between the library, the academic fraternity, and the institute management.

Composition of Library Governance /Committee:

The University's Vice Chancellor appoints the Library Committee (LC), a statutory committee. Various websites show the library governance as Vice-Chancellor as Chairman and Librarian as member Secretary. This is the most

common in all universities. Other members PVC, Registrar, are Deans, Chairman, External Library Experts, Students representatives, Faculty Representatives, invitee provision at some universities, Finance person, etc. There is a term period for Library Governance and sometimes rotation within the systems. This structure varies from library to library.

The composition of Dynamic Library Governance may be based on the following 8 principles of Good Governance by Amitav Banerji, a former diplomat and international civil servant, published in Global and National Leadership in Good Governance, UN Chronicle, 2015, UN.

Participation – Voice their opinion Rule of Law – Legal framework should be

enforced impartially

Consensus Oriented – A common minimum can be achieved

Equity and Inclusiveness – Assures an equitability

Effectiveness and Efficiency – Resources should be used for maximum output

Accountability – Accountable to stakeholders Transparency – Access to information

Responsiveness – Serve all stakeholders in a reasonable time

Strategic Vision - Strategic vision is ultimately the responsibility of the Board (Library Governance) added by BroadPro Software Company.

There are variations in the structure of the Library Governance, and information is not readily available on the website. There are no standard guidelines or norms for all universities from the UGC's end. No commission or committee has dealt much with it. The library budget part was discussed and suggested as a 6.5% share of the university budget. But I don't think it is judiciously followed; otherwise, our university libraries could be like foreign ones. For e.g., JNU

Library, IIMs, IITs, and Private University Libraries. The Library Governance Structure

varies from university to university. Only Academic books have mentioned library

governance. Research is required to study this area.

The library governance encounters some challenging issues mentioned here are to be solved.

- Increase the frontier of Librarianship.
- New Education Policy: Develop the collections in Indian Knowledge Systems
- Marketing of Resources
- Return on Investment
- Future value: moving from library use to library impact. The library plays a vital role for students in enrolment, retention and graduation, success, achievement, learning, student experience, research productivity, faculty grant proposals and funding, faculty and institutional teaching, reputation (ACRL report in OCLC newsletter 2010 issue 17)
- The library contributes to intangible assets like filling the knowledge gap, creating new knowledge, defeating fear, creativity, business opportunity guidance, increasing entrepreneurial ability, innovation, and design thinking, which is to be tapped through surveys.
- Contribution to the Institution
- As per the World Economic Forum: Geopolitics, Artificial Intelligence, Future of Work, Art and Culture, Rebuilding trust in the future, and The immediate challenges are climate and Nature.

- Disruptive technology (Cloud technology, Big data, 3d printer,
 5G technology, Al, Machine Learning)
- Work from home

The libraries connect to current and future requirements depending on how Dynamic it handles the situation.

Role and Responsibility of the Library Governance

It is a policy-making body for the library service, funds, books, staff, allocation of funds various activities. and writing unserviceable books or loss of books. The policies library functions according to prepared by the Library Governance or the committee. It helps with library planning and development activities. The Macro and Micro level activities of each library are described in the manual or website depending on how small, medium, and large the university library is in its size.

There is consistency in Library no Governance among various university library information websites. Some university libraries have details properly placed on their websites, and in the case of some universities, they can be found easily, but some universities do not keep any details. Structure of Library Staff, their duties in detail, and Rules and Regulations to run the library.

Conclusion:

Let me tell you that not much work has been done in the Library Governance area. I could not see any research in Shodhganga on Library Governance or committees. One can count the research papers on the fingertips Under the heading "Library Governance in University or University Library Governance." ILA, IASLIC, and MANLIBNET did not touch this topic directly. There is a scope of research for research papers on Library governance in India and a doctoral thesis on their scope and purpose, rules of procedure, and connection to institutional governance structures. One exciting paper I could see on

the opposite situation is Library Leadership in University Leadership and Governance by

Jessica Boyer in ACRL 2023 of ALA. Another promising research paper on The Role of

Library Councils in Canadian Higher Education: An Exploratory Study by Eva Revitt and Sean Luyk was published in 2019.

Introduction

The Prime Minister of India in his address to the Nation from the ramparts of the Red Fort on 15th August, 2022, had pointed out the importance of Research and Development in our country in the Amrit Kaal. He had given the clarion call of "Jai Anusandhan" on the occasion.

The National Education Policy, 2020 (NEP 2020) has also identified research as a corequisite for outstanding education and development in our country.

In response to the vision of making India Atmanirbhar and Viksitbharat@2 047, the Government of India approved One Nation One Subscription scheme to provide country-wide access to international high impact scholarly research articles and journal publications to students, faculty and researchers of all Higher Education Institutions managed by the central government and state

governments and Research & Development Institutions of the central government.

The One Nation One Subscription (ONOS) intends to acquire national

licenses for e-journal/database subscriptions from most of the prominent journal publishers. A total of 30 major international journal publishers have been included in ONOS. All the journals published by these publishers will be accessible to the students, faculty members and researchers of the participating institutions.

The initiative will open a goldmine of knowledge available in top quality scholarly journals to nearly 1.8 crore students, faculty members, researchers and scientists of all disciplines, including those in tier 2 and tier 3 cities, thereby encouraging core as well as interdisciplinary research in the country.

The ONOS is starting its operation from 1st January 2025. ONOS phase-I has been approved for the calendar years 2025, 2026 and 2027.

Access to journals are being provided through national subscription coordinated by the Information and Library Network (INFLIBNET) Centre, an autonomous inter-university centre of the University Grants Commission (UGC), Gandhinagar, Gujarat.

The Department of Higher Education, Government of India will have a unified portal "One Nation One Subscription" (https://www.onos.gov.in/) through which the institutions will be able to access the journals. The ANRF will periodically review the usage of One Nation One Subscription and publications of Indian authors of these institutions.

One Nation One Subscription is a timely step towards establishing India in the global research ecosystem by bringing ease of doing research to the doorstep of all students, faculty members and researchers in the government institutions.

Background

Before ONOS, access to subscription journals were being acquired through different library consortia of government departments, academic and R & D institutions; and through individual subscriptions by various higher education and R & D institutions.

ADINET ACTIVITIES


AMC Primary School Library Project
